

**VILLAGE OF VALEMOUNT
CEMETERY BYLAW NO. 685, 2012,
AMENDMENT BYLAW NO. 846, 2021.**

A Bylaw to amend the Village of Valemount Cemetery regulations regarding marker placements and cemetery fees.

The Village of Valemount Council, in open meeting assembled, enacts as follows:

1. CITATION

- 1.1 This Bylaw may be cited for all purposes as “Village of Valemount Cemetery Bylaw No. 685, 2012, Amendment Bylaw No. 846, 2021.”

2. AMENDMENTS

The following amendments are hereby made to Village of Valemount Cemetery Bylaw No. 685, 2012.:

- 2.1 The text in Section 11.13 will be deleted in its entirety.

- 2.2 The text in Section 15.2 f. will be deleted in its entirety and replaced with the following:

“f. Two memorial tablets will be permitted on each cremation grave space.

g. Two memorial markers will be permitted on each full burial grave space, with only one upright memorial permitted per space; the upright memorial will only be permitted if it is the first to be placed on the grave space.

h. Where two related persons are buried side by side in adjacent graves, one 45 cm x 75 cm (18” x 30”) tablet which provides for the memorialize of both persons may be used instead of two separate tablets provided the single tablet so used is set to embrace evenly the two graves concerned.”

Lettering in the remainder of Section 15 will be adjusted accordingly.

- 2.3 Schedule “B” will be amended as follows:

- 2.3.1 The following text will be deleted under “Additional Costs”:

CEMETERY AMENDMENT BYLAW NO. 846, 2021.

"After 4:00 pm on Weekdays (1-hour minimum charge) - \$100 per hour."

- 2.3.2 The following text will be added under "Opening & Closing Grave for Burial"

"Double depth burial - \$200 in addition to regular burial rates"

- 2.3.3 The following text will be added under "Additional Costs":


- a. *"Cribbing (Supplied by the Village) - Owner's expense, billed at cost"*
- b. *"Public Works labour after 3:00 pm on Weekdays (1-hour minimum charge) - \$100 per hour."*

READ A SECOND TIME this 8th day of June, 2021.

READ A THIRD TIME this 22nd day of June, 2021.
