\$1,500*

Pellet stove appliance replacement:

\$2,000*

Electric heat pump replacement:

\$3,500*

CSA/EPA certified stove (more than 5 years old) or secondary heat source alternative replacement:

\$1,000

*The replacement is eligible for an additional \$130 for permit/ inspection fees.

Rebates are to cover the cost of the appliance and the permit/ inspection fee if applicable. Any additional costs for the appliance, installation, materials etc. above the maximum rebate listed are the responsibility of the participant.

Is your current appliance eligible for replacement?

Eligible Stoves:

- Homemade or barrel wood stove
- Free-standing uncertified wood stove (not CSA B415/ EPA certified)
- An uncertified wood furnace (ducted, forced-air, home-heating appliance)
- A CSA B415/ EPA certified stove more than 5 years old (eligible for alternative replacement)
- An uncertified stove used as a secondary heat source replacement
- An uncertified wood burning insert installed in an open hearth
- A wood burning cook stove



How to Apply

Step 1:

Ensure your existing appliance is eligible for replacement. Please see the list of eligible appliances.

Step 2:

Complete the application form found on the Village website at www.valemount.ca or at the Village office - 735 Cranberry Lake Road. Return to the program coordinator with a photo of your existing appliance to be replaced.

Step 3:

Once approved, purchase your new appliance from the list of qualifying appliances to the right and have it installed in your home. Please note that the program will cover permit and inspection fees, in addition to your rebate, to a maximum of \$130.

Step 4:

Destroy your old stove (Remove doors, destroy flue collar, remove firebrick) take photos, and deliver the body to the Public Works Yard.

Step 5:

Ensure your application form is complete and return to the Program Coordinator with photos of the newly installed appliance and destroyed appliance. Your rebate will then be mailed to you by cheque.

What can I replace it with?

Eligible Replacements:

- A CSA B415/ EPA-certified wood stove or pellet stove
- A CSA B415/ EPA-certified wood insert, pellet insert, or an electric fire place insert that is not freestanding, installed in an existing open-hearth fireplace
- An electric heat pump that meets the criteria for the BC Hydro/ Home Renovation and CleanBC Better Homes rebates
- An CSA B415/ EPA certified wood or pellet furnace **ONLY** if it is replacing an existing uncertified wood-burning furnace
